Children and their moms attend from all over the Nation.

The primary focus of the Foundation is a one-week summer camp and various weekend retreats held on the Foundation's camp property in Colorado. In 2017, 88 children and 32 widows attended the summer camp. Additionally, 30 families were hosted during the weekend retreats. Feedback from the participants was 100% positive. The Foundation covered all expenses for the families to include airfare, lodging, camp fees, t-shirts, meals and all activities.

4b (Code: _____) (Expenses \$ 993418 including grants of \$ _____) (Revenue \$ _____)
In 2015, the Foundation purchased a 118-acre ranch in Colorado. The Foundation began a Capital Campaign to raise funds for the renovation of the property and the mortgage on the property. This purchase allowed the Foundation to expand it's programs and offer services to a larger audience on a more frequent basis. In 2017, the Foundation completed all of it's renovations to include construction of 6 new cabins, a bathroom and storage building at the tent camp and expansion of the existing kitchen. The cost of the building construction in 2017 was \$674,349. In addition to the construction costs, \$259,800 was paid towards the property mortgage in 2017. Annual operating costs for the property include utilities and repairs, which totaled \$19,369 for 2017. The Foundation purchased a tractor to use for upkeep on the property, which totaled \$21,000. Additionally, the Foundation entered negotiations for the purchase of an adjoining property. In-kind donation of \$18,900 in realtor fees was included as an expense in 2017. The purchase of the property was finalized in 2018. Funding for the construction, upkeep, mortgage, utilities and tractor came from the money raised during the three year-long Capital Campaign and was separate from the funds raised for program activities. The \$993,418 is listed as one line item in section IX, on line 24 d.

This included donation processing fees from online donation services, administrative costs to include office supplies, a financial review conducted by Capin Crouse and insurance for the property, board of directors and liability insurance.
