The Knights of Heroes Foundation provides mentorship to boys and girls who's fathers have died while serving our Nation as first responders or as members of the Armed Forces. The Foundation's primary activities include a one-week summer camp and four seasonal retreats hosted throughout the year. All activities are hosted on the camp property in Colorado. Families attend from across the Nation.

The primary focus of the Foundation is a one-week summer camp and four seasonal weekend retreats held on the Foundation's camp property in Colorado. In 2018, 100 children and 30 widows attend the summer camp. Additionally, 60 children were hosted during the weekend retreats. Feedback from the participants was 100% positive. The Foundation covered all expenses for the families to include airfare, lodging, camp fees, meals and all activities.

4b (Code:) (Expenses \$ 221,277 including grants of \$) (Revenue \$ 0)

In 2015, the Foundation purchased a camp property. Over the past three years we have conducted a capital campaign to pay off the mortgage and renovate the property. In 2018, the Foundation officially ended the campaign by paying off the property mortgage which amounted to \$203,768. Additionally, the Foundation completed renovations on the facilities. These renovations totalled \$17,509 in 2018.

Administrative and fundraising expenses totalled \$25,076 in 2018. The majority of these expenses were driven by Federal, State and county requirements for volunteer background checks, insurance, financial audits, etc. The fundraising expenses were primarily online giving transaction fees.
